By signing this certification and returning it to the offices of Musser Bros Inc., or an employee or contractor therein, I hereby certify that:

1. I understand that if I am the successful bidder, I will be required to sign the agreement of purchase and sale immediately upon notice of being the successful bidder.
2. I understand that a **5% Buyers Premium** will be added to my final bid to equal the contract price.
3. I understand that the Auctioneers are working for the Seller and there is no relationship of dual agency.
4. I understand that the property has not been surveyed for this auction. I understand that if the buyer desires a survey it will be at the buyer's expense. All acreage and footage is believed to be correct but is not guaranteed. This property is being sold subject to any existing right of way easements.
5. I inspected the property prior to bidding. I understand that all property is selling AS IS, WHERE IS and No warranties are expressed or implied.
6. I understand that the property contract will not be contingent upon my ability to obtain financing or any other reason. Upon becoming the high bidder, I understand that I will be required to sign a personal or certified check made for Ten Percent (10%) of the total contract price as an earnest money deposit. I understand that the earnest money deposit would be forfeited if I failed to close on this property.
7. Closing will take place not more than 45 days from the date of the auction.
8. I understand that the announcements made by Musser Bros Inc, at or prior to CLOSING of the bids, take precedence over any and all preprinted material.
